Sam Barum from One Star Long Distance visited with the board. The board will wait until we have the new T-1 lines in place for a while before switching long distance carriers. She will come back in about 6 months.

An easement of variable width more particularly described as follows: Commencing at the Center of Section 24, Township 75 North, Range 16 West of the 5th P.M., Mahaska County, Iowa; thence S-00°00'00"-E641.40 ft.; thence S-90°00'00"-W 181.15 ft. to the Point of Beginning; thence N-89°29'21"-W 83.00 ft.; thence S-04°30'54"-W 100.24'; thence S-00°30'39"-W100.00 ft.; thence S-11°49'14"-W 305.94'; thence S-00°30'39"-W 100.00 ft; thence S-18°00'37"-E210.92 ft.; thence S-89° 29'21"-E 66.00 ft.; thence N-16°25'06"-E 207.96 ft.; thence N-00°30'39" –E100.00 ft.; thence N-21°17'27"-W 107.70 ft; thence N-00° 30'39"-E400.00 ft. to the Point of Beginning containing 2.30 acres more or less. The East line of the NW ¼ of said section is assumed to bear S-00°00'00"-E for this description.
