In the Recorder's office there was \$60.00 in cash. In the Auditor's office there was no cash and \$7500.00 Certificate of Deposit for the Jackson Cemetery. In the Sheriff's office all money had been deposited with the Treasurer.

July 3, 2000

The Mahaska County Board of Supervisors met on the above date at 9:00 a.m. in the third floor conference room of the courthouse with the following present: Greg Gordy, Howard Groenendyk, Daryl Cox. Also present Kay Swanson, County Auditor and Dennis Luebbe, County Engineer. Darren Harrison from the Oskaloosa Herald. Chairman Gordy opened the meeting with a moment of silence.

The changes were to change to a 3 year plan and a 3 part plan. One written comment sent to Joleen was that the poverty level should be included in contract. It was moved by Cox seconded by Groenendyk to adopt the Managed Care Plan for Disabilities Services for the years beginning July 1, 2000 and ending June 30, 2003. All ayes. Motion carried.

It was moved by Groenendyk seconded by Cox to approve the Memorandum of Agreement for Case Management for the Frail Elderly between the Local Administrative entity and Local Agencies and Assurances for Case Management Programs for the Frail Elderly. Joleen Nelson, CPC is to be the County's representative on this committee. All ayes. Motion carried.

It was moved by Cox seconded by Groenendyk to approve the agreement with Mahaska County and County Life Health Care, Inc. for FY 2001. All ayes. Motion carried.

It was moved by Cox seconded by Groenendyk to approve the Lease Agreement with Country Life Health Care, Inc. for FY 2001and to authorize the chairman to sign. All ayes. Motion carried.

It was moved by Cox seconded by Groenendyk to approve the 28E Agreement regarding Insurance between Mahaska County, Iowa and Country Life Health Care, Inc. All ayes. Motion carried.

It was moved by Groenendyk seconded by Cox to not participate in the Wellness program for the employees of Mahaska County for 2000. All ayes. Motion carried.

At 10:15 a.m. the following individuals from the Lynn Ave. area visited with the board about Paving Districts. Bob Auld, Mike Foster, Don Houk, Ken Shilling and Bruce Peiffer. They are concerned with the dust problem and would like to have their road seal coated. They will put together a petition and file it with the board. The board will work on a county resolution.

It was moved by Cox seconded by Groenendyk to approve the Support Agreement with Solutions for FY 2001. All ayes. Motion carried.

It was moved by Groenendyk seconded by Cox to approve the Resolution for Interfund Operating Transfers. All ayes. Motion carried.

RESOLUTION FOR INTERFUND OPERATING TRANSFER

WHEREAS, IT IS DESIRED TO AUTHORIZE THE AUDITOR TO PERIODICALLY TRANSFER FUNDS FROM THE GENERAL BASIC FUND AND RURAL SERVICES BASIC FUND TO THE SECONDARY ROAD FUND DURING the 2000/2001 budget year, and whereas, said transfer must be in accordance with Section 331.432 of the code of Iowa,

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF MAHASKA COUNTY, IOWA as follows:

- Section 1. The total maximum transfer from the General Basic Fund to the Secondary Road Fund for the fiscal year beginning July 1, 2000 shall not exceed the sum of \$114,371.00 and the total maximum transfer from the Rural Basic Fund to the Secondary Road Fund for the fiscal year beginning July 1, 2000 shall not exceed the sum of \$1,250,996.00.
 - Section 2. On the quarterly basis after being notified of the apportionment of current property taxes, state replacements against levied property taxes, mobile home taxes, military services tax credit replacements, or livestock credit replacements to the General Basic or Rural Services Basic Funds, the auditor shall order a transfer from said fund to the Secondary Road Fund.
- Section 3. The amount of the transfer required by Section 2 shall be equal to the apportionment made under Section 2 to the General Basic or Rural Services Basic Fund, respectively, multiplied by the ratio of said funds total maximum transfer to the Secondary Road Fund, to the sum of said fund's total current property tax levy, total mobile home taxes, total military service tax credit replacements and total livestock credit replacements.
- Section 4. Notwithstanding the provisions of sections 2 and 3 of the resolution, total transfers shall not exceed the amounts specified in Section 1.
- Section 5. Notwithstanding the provisions of sections 2 and 3 the amount of any transfer shall not exceed available fund balances in the transferring fund.
- Section 6. The auditor is directed to correct his/her books when said operating transfers are made and to notify the treasurer and county engineer of the amounts of said transfers.

It was moved by Cox seconded by Groenendyk to approve the following resolution. All ayes. Motion carried.

WHEREAS, It is desired to make appropriations for each of the different officers and Departments for the fiscal year beginning July 1, 2000 in accordance with

Section 331.434 subsection 6, of the Code of Iowa.

- **NOW, THEREFORE, BE IT RESOLVED**, by the Board of Supervisors of Mahaska County, Iowa as follows:
- SECTION 1. The amounts itemized by fund and department or office on the following schedule are hereby appropriated from the resources of each fund as itemized, to the department or office listed.
- SECTION 2. Subject to the provisions of other county procedures and regulations, and applicable state law, the appropriations authorized under Section 1 shall constitute authorization for the department or officer to make expenditures or incur obligations from the itemized fund, effective July 1, 2000.
- SECTION 3. In accordance with section 331.437, Code of Iowa, no department or officer shall expend or contract to expend any money or incur any liability, or enter into any contract which by its terms involves the expenditures of money for any purpose in excess of the amounts appropriated pursuant to this resolution.
- SECTION 4. If at any time during the 2000/2001 budget year the auditor shall ascertain that the available resources of a fund for that year will be less than said fund's total appropriations, he/she shall immediately so inform the board and recommend corrective action.
- SECTION 5. Auditor shall establish separate accounts for the appropriations authorized in section 1, each of which account shall indicate the amount of appropriations, the amounts charged thereon, and the unencumbered balance. The auditor shall report the status of accounts to the applicable departments and officers quarterly during the 2000/2001 budget year.
- SECTION 6. The appropriations authorized to the resolution lapse at the close of business June 30, 2001.
