The Mahaska County Board of Supervisors met on the above date at 9:00 a.m. in the third floor conference room of the courthouse. Present were: Howard Groenendyk, Henry W. VanWeelden, Greg Gordy. Also present was Joe Albright and Dennis Houser from the Secondary Road Dept and Kay Swanson, County Auditor. Chairman Groenendyk opened the meeting with a moment of silence.

It was moved by VanWeelden seconded by Gordy to approve the agenda with the addition of discussion of direct deposit for paychecks and deleting the minutes. All ayes. Motion carried.

John Terpstra spoke to the board concerning a water line that is under the Beacon Bridge that is to be replaced this year. This water line is owned by the County K Water Board.

Tom Jackson, Pete Fynaardt, Charles Oldham, Larry Linsley, and Lyle Blom from the Farm Bureau discussed the fund balances with the board. As part of the budget process they encouraged the board to not have a large fund balance at the end of year. They were appreciative of what the board has done in the past to keep property taxes as low as possible.

It was moved by Gordy seconded by VanWeelden to provide Direct Deposit for employees paycheck at Mahaska State Bank as our clearing bank. Their will be a .15 cent charge for each transaction per employee that does not bank at Mahaska State Bank. This will begin around the first of April. All ayes. Motion carried.
