Mr. Charles Russell, Chair of the Historic Preservation Committee spoke to the board about requesting funds for the Frankel Building on South Market Street. The building has collapsed and they are requesting funds to restore the building. They have put a cap on the cost of the renovation at \$190,000.00 and so far they have raised approximately \$183,000.00. Michelle Fagerstone from Main Street also spoke to the board about this building. It was moved by VanWeelden to give \$10,000.00 to this fund based on the outcome of the consulting engineer's report. The motion died for a lack of a second. No further action was taken today.

STOP AT INTERSECTION MUTCD 2B-5

RESOLUTION
