10:55 a.m. It was moved by Groenendyk seconded by Gordy to return to open session. All present voted aye. Motion carried. It was moved by Gordy seconded by Groenendyk to deny services for this individual for November. All present voted aye. Motion carried.

Charles VanToorn, Mahaska County Sheriff and County Attorney Charles Stream and Joleen Arnold, CPC for Mahaska County discussed the bills for drugs for mental health inmates at the jail. It was moved by VanWeelden seconded by Groenendyk to have the mental health department pay these delinquent drug bills. All present voted aye. Motion carried.

It was moved by Groenendyk seconded by Gordy to instruct the County Attorney to proceed with legal settlement on the bills for the drugs at the jail. All present voted aye. Motion carried.

Sone Scott, newly elected Treasurer of Mahaska County, Arlene Weidmann, current Treasurer of Mahaska County and Kim Snook from the Iowa Department of

Transportation discussed the county issuing driver's licenses. No decisions were made today.

Marla Knight from Iowa Telecom presented the board with a proposal to change the phone lines from Qwest to Iowa Telecom. The board will study this and she will come back to the December 2, 2002 meeting.

The board discussed courthouse space again. No decisions were made today.
