Chairman VanWeelden called the meeting to order with a moment of silence.

It was moved by Rouw seconded Gordy to approve the minutes of July 1st meeting. All present voted aye. Motion carried.

Don Russell, Mahaska County Sanitarian discussed the letter the county attorney wrote for him to send to the contractors who install or re-construct on-site septic systems in Mahaska County. It was moved by Gordy seconded by Rouw to approve the letter and for Don Russell to mail it by registered mail to the contractors. All present voted aye. Motion carried.

Don Russell gave the board a letter complaining about standing water along a roadway.

It was moved by Rouw seconded by Gordy to approve the following contract for Mental Health Services. All present voted aye. Motion carried.

CONTRACT FOR MENTAL HEALTH SERVICES BETWEEN MAHASKA COUNTY AND MAHASKA HEALTH PARTNERSHIP COMMUNITY HEALTH

THIS AGREEMENT entered into this 1st day of July, 2008 by and between Mahaska County, and legal subdivision of the subdivision of the State of Iowa, hereinafter referred to as "County", and Mahaska Health Partnership Community Health, a non-profit agency, hereinafter referred to as provider.

Now, therefore the parties do hereby mutually agree as follows:

- I. The County agrees:
 - 1. To provide training on the CPC process.
 - 2. Issue funding agreement when appropriate.
 - 3. Pay all claims in a timely fashion.
 - 4. Will comply with all state and federal laws / rules on confidentiality.
 - 5. Will comply with HIPAA guidelines.
 - 6. Will comply with the Mahaska County managed care plan.
 - 7. Will assist in completing CPC Applications for new clients.
- II. The Provider agrees:
 - 1. To provide mental health services as outlined in provider profile at rates outlined in provider profile. (see attached)
 - 2. To comply with all federal / state rules / laws.
 - 3. To comply with HIPAA guidelines.
 - 4. To provide billing in a timely manner.
 - 5. Comply with Mahaska County managed care plan.
 - 6. Will assist in completing CPC Applications or refer client directly to CPC for assistance.
- III. The County and Provider mutually agree:
- A. Effective date:
 - 1. This agreement shall begin on July 1, 2008, at 12:01 AM,
 - 2. This agreement shall end on June 30, 2009, at 12:00 midnight.
- B. Assurance of Civil, Human and Legal Rights of County Residents:

1. The civil, human and legal rights of County residents utilizing the services of the provider shall be protected, specifically including the right to decline disclosure of the resident's name, or other readily recognizable identifying information.

2. The refusal of a County resident to disclose information, or to secure information, or to secure information about him or her, by the staff of the Provider shall not be justification for denying the clinical services to said County resident, except in cases in which such disclosures or securing information is deemed by the County as necessary to the effective utilization of said services, or as may be required by Iowa Law.

C. Renegotiation or Modification:

Any alterations, variations, modifications, or waivers of provisions of this agreement shall only be valid when they have been reduced to writing duly signed, and attached to the original of this agreement. The parties agree to

renegotiate this agreement if Federal or State revision of any applicable laws or regulations make amendment to this agreement necessary.

D. Financial Support Plan:

1. Funding of all third party insurance options will be reasonably pursued for reimbursement prior to county coverage.

2. Reimbursement rates listed as an attachment in the provider profile will be followed for county eligible clients.

E. Termination:

This agreement, or part of this agreement, may be terminated by either party at any time, upon no less than six months notice in writing to the other party. Said notice shall be delivered by certified mail or in person.

F. All terms and conditions included in agreement:

This agreement contains all terms and conditions agreed upon by the parties. No other agreements oral or otherwise, regarding the subject matter of this agreement, shall be deemed to exist, or to bind any of the parties hereto.

The parties hereto have caused this agreement to be executed by their officials thereunto duly authorized.

AGREEMENT

AGREEMENT MADE and executed this 1st day of July, 2008, by and between the Mahaska County Hospital doing business as Mahaska Health Partnership, acting by and through its duly constituted Board of Trustees (hereinafter referred to as "the hospital"); Mahaska County, Iowa, acting through its duly constituted board of Supervisors (hereinafter referred to as "the county"); and the Mahaska county, Iowa, Board of Health, acting by and through its board (hereinafter referred to as "the board"); as follows:

WHEREAS, the hospital is a duly organized and operating county hospital, operating under the laws of the State of Iowa, and is desirous of assuming the services imposed upon by the board by statute or administrative rule. Services shall be provided in compliance with IAC 641-80 and as identified in the grant application. Proposed changes in service shall be based upon identified needs and submitted to the Contractor.

WHEREAS, the county is desirous of entering into an agreement for the provision of the services imposed upon the board by statute or administrative rule. Services shall be provided in compliance with IAC 641-80 and as identified in the grant application. Proposed changes in service shall be based upon identified needs and submitted to the Contractor.

WHEREAS, the board is desirous of entering into an agreement for the provision of services imposed upon the board by statute or administrative rule. Services shall be provided in compliance with IAC 641-80 and as identified in the grant application. Proposed changes in service shall be based upon identified needs and submitted to the Contractor.

WHEREAS, the parties understand that this agreement relates to services imposed upon the board by statue or administrative rule. Services shall be provided in compliance with IAC 641-80 and as identified in the grant application. Proposed changes in service shall be based upon identified needs and submitted to the Contractor.

IT IS THEREFORE AGREED by and between the parties as follows:

1. This agreement shall be effective commencing July 1, 2008, and shall continue until June 30, 2009.

2. The hospital shall assume and perform, in good faith, all services of the board, including those heretofore performed by the board, including such services as are now or may hereafter be imposed upon the board by statute or administrative rule, including, without limitation, those services set for the by and IAC 641-80. The hospital and BOH will comply with the Local Public Health Services special and general conditions as well as related documents for the fiscal year the agreement applies. The hospital shall have the right to determine the method and means to most efficiently discharge the services imposed on it by this agreement, subject to the right and duty of the board to review and make recommendations to the hospitals board of trustees and hospital administration. The hospital shall be responsible for final policy, program, and agency evaluation.

3. The hospital shall keep all records, reports, and memoranda complied, in performance of the services set forth in paragraph two (2) herein. They shall make and file all reports in a timely manner as required by statute or administrative rule, or required

by the terms and conditions of any grant or other program with the appropriate governmental unit or other authority or agency requiring the same; and shall provide copies of such to the board on a quarterly basis. The hospital shall maintain confidentiality of all medical records.

4. The county shall continue to maintain family health and dental insurance for the three employees maintained on the county insurance policy prior to April 1, 1994. The hospital agrees, on a monthly basis, to reimburse the county the full dollar amount for said insurance premiums. It is further agreed that the above described employees and the hospital shall have the option of enrolling said employees in the hospital medical plan if appropriate.

5. The hospital will continue to provide services to Mahaska County residents without regard to their ability to pay for such services. A sliding fee schedule will be used when appropriate.

6. The County will reimburse the hospital \$125,000 (with the proposed budget of \$70,000 for Public Health services and \$55,000.00 for Home Care Aid services) contracted and rendered in FY07/08 for services pursuant to the within agreement. Payments for services provided will be billed Bi-Monthly to the county by the hospital. In addition, the board agrees to allocate all funds from the Iowa Department of Public health to the hospital for services provided pursuant to this agreement to the hospital under the single county contract also known as the LPHS contract. Any adjustments .made to the LPHS contract during the FY by the IDPH will be passed onto the hospital by the county.

7. The hospital shall obtain any necessary licenses, permits, or other authority to perform its duties thereunder and shall furnish proof thereof at the request of the board.

8. The BOH is responsible for assuring compliance by the hospital with the requirements for Iowa Administrative Code 641 .Chapter 80.

9. This agreement can be terminated only upon written notice to be served 90 prior to the end of each contract period.

10. Upon termination of this agreement the hospital shall forthwith, deliver to the board all records in its possession relative to the duties carried out by the hospital pursuant to this agreement.

11. If notice of termination is not given pursuant to paragraph thirteen, this agreement shall automatically renew at the end of each contract period for an additional one-year term. An addendum which includes the LPHS contract face sheet amounts as well as signatures of all parties will be executed annually. This face sheet attachment represents the Local Public Health Services Grant awarded for FY 09.

12. This agreement shall be amended only by a written agreement executed by all parties.

13. All notices which may need to be served herein shall be sent by regular mail to Jay Christensen, on behalf of the hospital, and to the County Board of Supervisors, on behalf of the County.

SMOKING AND TOBACCO USE POLICY For Mahaska County Employees Issued: June 30, 2008

1. Notification and Effective Date

All Mahaska County employees (herein "employees") must read this Smoking and Tobacco Use Policy, and will be expected to sign an Acknowledgement indicating that they have read and fully understand the policy. All employees must abide by the standards set forth in this policy. This policy is effective July 1, 2008.

2. General Statement of Policy

This policy is intended to help Mahaska County employees comply with Iowa's Smokefree Air Act. This law was enacted to improve the health of lowans by reducing their level of exposure to environmental tobacco smoke. For more information on the rules adopted to implement the Smokefree Air Act see 641 Iowa Administrative Code 153 and 11 Iowa Administrative Code 100.3.

3. Prohibited Activities

Smoking is prohibited:

1. Inside of all buildings leased, occupied, operated or owned by the state, counties or other political subdivisions;

2. Inside of all county operated/owned vehicles, except those ordered to receive a regular registration plate pursuant to Iowa Code section 321.19;

3. On the grounds of any building occupied by Mahaska County staff. "Grounds" is defined as an outdoor area of a public building that is used in connection with the building, including but not limited to, a sidewalk immediately adjacent to the building; a sitting or standing area immediately adjacent to the building; a patio; a deck: a courtyard; or any other outdoor area as designated by the person having custody or control of the public building: and

4. In any areas formerly used as smoking areas.

4. Permitted Activities

Smoking is permitted inside of enclosed privately-owned motor vehicles located on public property.

5. Violations

Violations of this policy may result in disciplinary action.

6. Employee Assistance

Mahaska County recognizes that employees may need assistance in stopping the use of tobacco products. The County offers the following information for assistance in the transition process:

a. Iowa Smoke Free Air Website - Iowa Department of Public Health's website. www.IowaSmokefreeAir.gov is a good resource regarding the smoking ban legislation, including information about smoking cessation programs. Quitline Iowa provides free smoking cessation services to all lowans. The Quitline will work with you to set up a quit plan and help you with coaching after you quit. You may also qualify for a free, 2-week course of nicotine patches or gum. Call 1-800-QUIT-NOW (1-800-784-8669) or visit www.quitlineiowa.org for more information.

RESOLUTION AREA SERVICE "C" ROADS

WHEREAS: Mahaska County desires to classify certain roads on the area service system in the County to provide for a minimal level of maintenance and access by means of a gate or barrier; and

WHEREAS: the County, after consultation with the County Engineer, has the authority to specify certain roads within the County as Area Service "C" roads pursuant to Iowa Code Section 309.57 (1995) as amended by House File 419 (1996); and

WHEREAS: the following road shall be classified as an Area Service "C" road:

A road 66 feet in width described as follows: beginning near the SW Corner Section35-77N-R14W thence easterly to near the S¹/₄ of the SE¹/₄ Section 35-77N-R14W in Pleasant Grove Township. Said road is also known as 160th street between Victoria and Yale Avenue.

1. Blading: Blading or dragging will not be performed on a regular basis.

2. Snow and Ice Removal: Snow and ice removal will not be performed on a regular basis. Sanding and salting will not be performed on a regular basis.

3. Bridges: Bridges on Area Service "C" roads may not be maintained to carry legal loads but will be posted as appropriate to advise of any load limitations.

4. Weeds, Brush, and Trees: Mowing or spraying weeds, cutting brush and tree removal will not be performed on a regular basis. Adequate sight distances will not be maintained on a regular road.

5. Structures: Bridges and culverts may not be maintained on a regular basis to carry legal loads. Upon failure or loss, the replacement structure will be for traffic thereon.

6. Road Surfacing: There will be no surfacing materials applied to Area Service "C" roads.

7. Shoulders: Shoulders will not be maintained.

8. Crown: A crown will not be maintained.

9. Repairs: There will be no road repairs on a regular basis.

10. Uniform Width: Uniform width for the traveled portion of the road will not be maintained.

11. Inspections: Regular inspections will not be conducted.

12. Gate: The gate shall be purchased and installed by the County and maintained by the adjoining landowners. If not so maintained, the County may remove the gate; and

WHEREAS, the only persons who will have access rights to the road shall be:

a. the owner, lessee, or person in lawful possession of any adjoining land, b. the agent or employee of the owner, lessee or person in lawful possession of any adjoining land,

- c. any peace officer,
- d. any magistrate,
- e. any public employee whose duty it is to supervise the use or perform maintenance of the road,
- f. any agent or employee of any utility located upon the road.

THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF

MAHASKA COUNTY that this County does hereby establish the road described as an Area Service "C" road, with restricted access and a minimal level of maintenance.

They showed the board pictures and the plans. Planned letting date is November 18, 2008. Projected cost of this project will be 4.2 Million.

It was moved by Gordy seconded by VanWeelden to adjourn. All present voted aye. Motion carried.
