## February 18, 2014

The Mahaska County Board of Supervisors met in regular session on the above date at 9:00 a.m. in the third floor conference room of the Mahaska County courthouse. Present were the following board members: Chairman ó Mike Vander Molen; Vice chairman ó Mark Doland; Member ó Greg Gordy. Chairman Vander Molen opened the meeting at 9:00 a.m. with a moment of silence.

Supervisor Doland presented a draft of steps to be taken in the engineer hiring process created with the input from Dan Gleason of the mayor¢s council. The board will

take this process under consideration as it gets closer to the March  $14^{\rm th}$  deadline for applications to be submitted.

Employee Handbook update progress was discussed.

Committee reports: Supervisor Doland reported the 10-15 Transit Board has been working toward a fixed bus route in Oskaloosa and is looking at funding available at 80% for a newly created route.
