

**May 2, 2018**

The Mahaska County Board of Supervisors met in regular session on the above date at 9:00 a.m. in the third floor conference room of the Mahaska County courthouse. Present were the following board members: Chairman ó Henry VanWeelden; Vice chairman ó Mark Groenendyk; and Member ó Mark Doland. Also present were Amanda DeVore, CRI; Ken & Ginger Allsup, Osky News; Charlie Comfort; Dave Shanahan, Engineer; Russ VanRenterghem, Sheriff; Carla Malloy; Steve Wanders; and Susan Brown, Mahaska County Auditor. The meeting was filmed by Communications Research Institute of William Penn University.

Chairman VanWeelden opened the meeting at 9:00 a.m. with a moment of silence.

It was moved by Groenendyk seconded by Doland to approve the agenda for today's meeting. All present voted aye. Motion carried.

Public Comments: Ken Allsup raised questions regarding Supervisor Doland's legal residence address.

It was moved by Doland seconded by Groenendyk to approve the minutes of April 18 ó 9:00 am & 6:30 pm. All present voted aye. Motion carried.

It was moved by Groenendyk seconded by Doland to approve the bills for the month of April totaling \$745,135.02. All present voted aye. Motion carried.

It was moved by Groenendyk seconded by Doland to add Shawn Ridenour to payroll in the Secondary Road department as full time truck driver/laborer with six month probationary period effective May 7, 2018. Rate is \$19.40/hr which is 90% of total wage for the position. All present voted aye. Motion carried.

It was moved by Groenendyk seconded by Doland to add Jessie Cranston to payroll in the Sheriff's department as part time jailer effective April 23, 2018. Wage is \$12.00/hour. All present voted aye. Motion carried.

It was moved by Groenendyk seconded by Doland to approve the following medical, dental and vision rates per month effective July 1, 2018. Medical: Single - \$524; Family - \$1277; Dental: Single - \$30; Family - \$70; Vision: Single - \$11; Family - \$22. Life: for employee only - \$2.20. All present voted aye. Motion carried.

It was moved by Doland seconded by Groenendyk to set public hearing for Mahaska County budget amendment for FY18 on May 16 at 9:00 a.m. All present voted aye. Motion carried.

It was moved by Groenendyk seconded by Doland to approve and authorize signature on Dissemination Agent Agreement with Northland Securities to cover county

for any material event changes and annual filing of required disclosures in relation to current bonding. All present voted aye. Motion carried.

Second reading of Ordinance #26 was held. It was moved by Groenendyk seconded by Doland to waive third reading and adopt Ordinance #26. All present voted aye. Motion carried.

### **SPEED RESTRICTION ORDINANCE**

Mahaska County Ordinance No. 26

**AN ORDINANCE RESTRICTING THE SPEED OF MOTOR VEHICLES ON SECONDARY ROADS IN MAHASKA COUNTY, IOWA**

**BE IT ENACTED** by the Board of Supervisors of Mahaska County, Iowa:

**SECTION I** ó Short Title: The Ordinance shall be titled as the Mahaska County Speed Ordinance

**SECTION II** ó Purpose: This Ordinance empowers the Board of Supervisors of Mahaska County, Iowa to establish speed restrictions pm Secondary Roads and the County Conservation Parkway road system within Mahaska County, Iowa.

**SECTION III** ó Definitions: For use in this Ordinance certain terms or words used herein shall be interpreted or defined as follows:

1. Secondary Road. These roads are under the County of Mahaska, Iowa jurisdiction
2. Board. The Mahaska County Board of Supervisors
3. County Conservation Parkways. Those Parkways defined as County Conservation Parkways under Code of Iowa, Sec.306.3

**SECTION IV** ó Authority: Mahaska County Board recognizes that the Iowa Code sets speed limits on all roads and streets with respect to the surface type and use. However, Iowa Code Section 321.285(5) does provide for setting speed limits not listed in the code.

**SECTION V** ó Special Speed Restrictions: The Board has determined on the basis of engineering and traffic investigations that the speed limits at the following Secondary Road location or location(s), are greater than is reasonable and proper under the conditions found to exist. The Board therefore determines and declares the reasonable and proper speed limit at the following secondary road location or location(s) effective when the appropriate signs giving notice of the speed limits are erected by the Board.

**SECTION VI** ó SPECIAL 25 M.P.H. Speed Zone or Zones(s). A speed in excess of Twenty-five miles per hour shall be unlawful in the following designated road section or section(s):

1. G-77: From a Point 500 feet East of the East Property line of the Eddyville-Blakesburg School Property line to 500 feet West of the West Property line of the Eddyville-Blakesburg School Property line.

**SECTION VII** ó Penalties: Any Person found in Violation of this Ordinance shall be guilty of a simple Misdemeanor and Subject to the Fines as set forth in the current State of Iowa compendium of Scheduled Violations and Scheduled Fines.

**SECTION VIII** ó Repealer: All Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed. Upon the effective date of this

ordinance the current speed limits of 35 and 45 M.P.H. for this section of roadway are repealed.

SECTION 1X ó Severability Clause: If any Section, Provision, or Part of this Ordinance shall be adjudged unconstitutional or otherwise invalid, such adjudication shall not effect the validity of the Ordinance as a whole or any section, provision, or part there of not invalid or unconstitutional.

SECTION X ó When Effective: This Ordinance shall be effective after the final passage, approval, and publication as provided by law and erection of signs giving notice as provided by law.
