## May 16, 2018

The Mahaska County Board of Supervisors met in regular session on the above date at 9:00 a.m. in the third floor conference room of the Mahaska County courthouse. Present were the following board members: Chairman ó Henry VanWeelden; Vice chairman ó Mark Groenendyk. Also present were Troy Bemis, Maintenance Director; Angie Holland, Oskaloosa Herald; Darin Hite, IT Director; Deann De DeGroot, MCARD; Russ Van Renterghem, Sheriff; Steven Wanders; Hailey Brown, Journalist; Dave Sedivec, Conservation Director; David Shanahan, Engineer and Jody VanPatten, Mahaska County Deputy Auditor.

This meeting was filmed by Communications Research Institute of William Penn University.

Chairman VanWeelden opened the meeting at 9:00 a.m. with a moment of silence.

It was moved by Groenendyk seconded by VanWeelden to approve the agenda with removal of item #15 request for mailbox placement for todaysø meeting. All present voted aye. Motion carried.

Public Comments: None

It was moved by VanWeelden seconded by Groenendyk to open public hearing for the amendment to the Mahaska County FY17/18 budget. All present voted aye. Motion carried. The notice of time and place of public hearing has according to law and as directed by the board been published on May 3, 2018 in both the Oskaloosa Herald The Sun. The affidavits of said publications are on file with the County Auditor. There were no comments received. It was moved by VanWeelden seconded by Groenendyk to close the public hearing. All present voted aye. Motion carried.

It was moved by VanWeelden seconded by Groenendyk amend and appropriate the FY17/18 Mahaska County budget as published. All present voted aye. Motion carried.

Revenues by Service Area: Penalties, Interest & Costs on Taxes - \$2,561; Intergovernmental - \$381,220; Licenses and Permits - \$6,683: Charges for Service - \$6,560; Use of Money and Property - \$33,050; Miscellaneous - \$525,545; Other Financing Sources - \$3,189,723.

Expenditures by Service Area: Public Safety & Legal Services - \$466,063; Physical Health & Social Services - \$1,078; County Environment & Education - \$28,769; Administration - \$98,359; Non-program Current - \$156,000; Debt Service - \$239,975; Capital Projects 6 2,379,923.

It was moved by Groenendyk seconded by VanWeelden to appoint Fred Bridges to Veteranøs Affairs Commission for a term of three years expiring June 30, 2021. All present voted aye. Motion carried

# 28E Agreement

This Agreement, entered into by and between the Town of Beacon, Iowa, a municipal corporation, hereinafter called õthe Townö, and Mahaska County, Iowa, a political subdivision, hereinafter called õthe Countyö, is duly authorized by Chapter 28E of the Code of Iowa.

The Town desires to have law enforcement services and the County, through the Office of the Sheriff, has the manpower and equipment necessary to provide said services. Therefore, the said Town and County, is a spirit of cooperation between these public agencies, agree with each other under the following terms and conditions as follows:

- 1. The County shall provide, through the Office of the Sheriff, law enforcement services and all men and equipment necessary therefore to said Town.
- 2. The said law enforcement services shall consist of patrol and traffic enforcement which shall be provided to said Town for a minimum of six hours per week.
- 3. The Town shall pay the County the sum of \$3,400.00 per year as reimbursement for expenses in relation to carrying out this Agreement.
- 4. The major portion of payment for said service shall be through the Town purchasing equipment for the office of the Sheriff and receiving credit for the cost thereof. The said equipment shall be selected and approved in advance by the Sheriff. Any balance shall be paid to the General Fund of the County.
- 5. The duration of this Agreement shall be for one year and neither party may terminate it without the express written permission of the other party.

- 6. This Agreement shall commence on the 1<sup>st</sup> day of August, 2018.
- 7. This Agreement shall be supervised by the Mayor and Council of the Town and Sheriff of the County.
- 8. In accordance with Section 28E.7 of the Code of Iowa, 2017, this Agreement does not relieve any of the parties hereto of any obligation or responsibility imposed upon it or them by law, except that to the extent of actual and timely performance thereof by any contracting party hereto, said performance may be offered in satisfaction of the obligation or responsibility.
- 9. The Town shall file a copy of the Agreement with the Secretary of the State and cause a copy hereof to be recorded with the County Recorder.
- 10. The provisions of Chapter 573A of the Code of Iowa, 2017, for termination of agreements in the event of a national emergency, apply to this Agreement. Dated this 16<sup>th</sup> day of May, 2018.

#### 28E AGREEMENT

This Agreement, entered into by and between the Town of University Park, Iowa, a municipal corporation, hereinafter called õthe Townö, and Mahaska County, Iowa, a political subdivision, hereinafter called õthe County, is duly authorized by Chapter 28E of the Code of Iowa.

The Town desires to have law enforcement services and the County, through the Office of the Sheriff, has the manpower and equipment necessary to provide said services.

Therefore, the said Town and County, is a spirit of cooperation between these public agencies, agree with each other under the following terms and conditions as follows:

- 1. The County shall provide, through the Office of the Sheriff, law enforcement services and all men and equipment necessary therefore to said Town.

The said equipment shall be selected and approved in advance by the Sheriff. Any balance shall be paid to the General Fund of the County.
- 5. The duration of this Agreement shall be for one year and neither party may terminate it without the express written permission of the other party.
- 6. The Agreement shall commence on the 1<sup>st</sup> day of July, 2018.
- 7. This Agreement shall be supervised by the Mayor and Council of the Town and Sheriff of the County.
