The Mahaska County Board of Supervisors met on the above date at 9:00 a.m. in the third-floor conference room of the Mahaska County courthouse. Present were the following board members: Chairman – Mark Groenendyk, Vice Chairman – Steve Wanders and Member – Chuck Webb. Chairman Groenendyk opened the meeting with the Pledge of Allegiance.

Heidi Kuhl addressed the board and explained the finance plan and recommended they approve Resolution #2024-13. Proceeds from the Notes will be used to provide interim financing to cover costs incurred related to the County's SE Connector project and the G29 County Road project and to pay costs associated with the issuance of the Notes. The wire will be sent to the County on June 18 and will allow the interfund loan of \$605,000 to be paid prior to the end of the current fiscal year.

Supervisor Chuck Webb introduced and moved the adoption of the resolution next hereinafter set out, approving a certain Note Purchase Agreement and authorizing the issuance of a General Obligation Urban Renewal Loan Agreement Anticipation Project Notes, Series 2024A in the principal amount of \$4,775,000; seconded by Supervisor Steve Wanders. After due consideration, the Chairperson put the question on the motion and the roll being called, the following named Supervisors voted:
