It was moved by Wanders seconded by Webb to approve the 4th quarter report from Veterans Affairs. All present voted aye. Motion carried.

It was moved by Wanders seconded by Webb to approve the Nyhart service agreement for the filing of the 509A Actuarial Certification. All present voted aye. Motion carried.

It was moved by Wanders seconded by Webb to approve the payroll changes for the Courthouse. Kaydee Jackson resigned from her position as courthouse custodian as of July 18th, 2024. Zachary Kauffman accepted the position of Maintenance Director and will be added to the payroll effective July 16th, 2024, with a 90-day probationary period. His starting salary will be \$26.93 per hour. Per the wage comp plan, this is pay grade 17, start level. All present vote aye. Motion carried.

It was moved by Wanders seconded by Webb to approve the payroll changes for Secondary Roads. David Markham has been hired with Job Classification 1 (truck driver & laborers) at a base hourly wage rate of \$26.80. His start date is Aug. 2nd, 2024. Per the Mahaska County Employee guidebook, he will start employment with 2 days of personal time. All present vote aye. Motion carried.

It was moved by Webb seconded by Wanders to approve the payroll changes for the Sheriff's office. Brandon Husmann resigned from his position as Deputy Sheriff. His last day will be Aug. 8, 2024. Sr. Jailer, JR Draughn, resigned and his last day will be Aug. 10, 2024. All present vote aye. Motion carried.

It was moved by Wanders seconded by Webb to approve the 28E agreement for Police Protection Services for the City of Fremont for FY23/24 and FY24/25 in the amount of \$6,250. All present voted aye. Motion carried.

It was moved by Wanders seconded by Webb to not enact the Natural Conservation / Wildlife / Open Prairie program within Mahaska County. All present vote aye. Motion carried.

It was moved by Wanders seconded by Webb to appoint Zach Kauffman as the ADA and Safety Coordinator. All present voted aye. Motion carried.

Member Webb called Mike Jensen with Shive-Hattery. He was placed on speaker phone. It was moved by Webb seconded by Wanders to approve the design for the removal and replacement of the LEC plumbing system and allow Shive-Hattery to move forward with the bid letting process using various alternate designs. Mike is going to revise the specification to reflect current dates for the bid process. All present voted aye. Motion carried.

The board discussed the process for reviewing applications and performing interviews to replace Darin Hite, County IT Director. Chad Gustafson with Heartland Business Systems has offered to assist with the interview process. It was moved by Wanders seconded by Webb to use the same process that was used last month for the Maintenance Director position. The Board, along with Chad Gustafson and Brian Knudtson, will rate the applications based on their qualifications and submit their rankings to Paul Greufe. Paul will score the applicants based on the ratings received and schedule interviews. Chair Groenendyk has been given authority to create an interview committee and to conduct the process. All present voted aye. Motion carried.

The board discussed the possibility of hiring an Economic Development Director. Member Webb has been having conversations with outside communities and Shea Greiner. The Chamber provided Chuck with a list of what they are doing to support New Sharon. Based on this information, hiring Shea would be duplicating efforts. The board will not move forward with the hiring of an Economic Development Director until there is a need. The Mayor of New Sharon is on board with this.
